- b) Tami Shepphird (with LA City Animal Services) will discuss current actions concerning development of Accessory Dwelling Units (ADUs) adjacent to properties zoned for horse keeping and LADBS interpretation of setbacks if an unlicensed horse is residing on the property (including if no horses are currently residing on the adjacent property).
