- 5. Safe Parking LA wanting to locate at 10824 Topanga Canyon, the Chatsworth United Methodist Church. The program is to allow private properties to host "homeless parkers" overnight.
- 6. 9110 DeSoto (closed Lamplighter) requesting demolition of existing restaurant to construct an 82,347 sq. ft. commercial development including a four story 45ft. tall 79,847 sq. ft. storage unit and a one story, 2500 sq. ft. convenience store and gas station. Requesting a zone change from P-1 and M2-1 to C2-1. CUP approval to allow 1) a reduction in required parking of no more than 20% 2) the sale of beer/wine for off-site consumption in conjunction with the convenience store/gas station 3) deviations from Mini-Shopping requirements to operate 24 hours a day and to install a pole sign 4) storage of household goods in the C-2 zone.
