Presenters: LA Equestrian Advisory Council (LAEAC) – Holding a meeting with the CNC Equestrian Committee in August to discuss current actions the group is involved in, one of which is the newly acquired equine staging area offered for use during emergencies by the Vulcan Materials Company site in Sun Valley. The sand and gravel quarry comprises several acres of usable, safe staging of horses in the event of a local fire similar to the one experienced last year (Creek Fire in the Hansen Dam area).

5. Other Business and Possible Motions

Review of the current budget developed for next year's Day of the Horse, a motion to approve the budget will be the first item on the agenda for the August meeting prior to the LAEAC meeting presentation.
