New building 75,118 sq. ft. with Mezzanine 8,352 sq. ft. Existing building 125,000 sq.ft. with 1300 sq.ft. to be demolished. Total area on site 198,818 sq.ft.

Discussion and possible letter concerning Senate Bill 50 (Senator Weiner) This bill would override local zoning regulations and require approval of high density, increased height, development projects in any zone including single family residential zones, within a half mile of a "job rich area" or major transit stop" and 55 feet or five stories within a quarter mile radius of major transit stop. Eliminates minimum parking requirements for new developments.
