- C. **Motion:** To approve the April 2020 MER.
- D. **Motion:** To approve the amended Board budget dated 5.19.2020.
- E. **Motion**: To approve up to \$4000.00 to trim and remove the ground overgrowth at the historical olive trees along Lassen between Topanga Canyon Blvd. and Farralone Ave.
- F. **Motion:** To approve up to \$800.00 to The Mailroom for Website Update/Changes.
- G. **Motion:** To approve \$1500.00 for Glenn Bailey as Selection Administrator (Neutral Third Party) for the CNC Selection. Payment was previously approved for his work on the 2020 Selection.
- H. **Motion:** To aprove an NPG for \$8,000.00 to ADOPT the CITY INC their pop-up food pantry. Each Wednesday, at noon, upwards of two hundred bags of food are distributed to those in need. This donation will extend the program, with the current demand, until August 2020
- I. **Motion:** To approve an NPG for \$2,000.00 to the North Valley YMCA for day care supplies. The North Valley YMCA has started a day care program for children of First Responders.
- J. Motion: To approve an NPG for \$2000.00 to the Guadalupe Center food pantry.
- K. **Motion:** To approve an NPG to the Fireman's Foundation for \$500.00 to replace the Jaws of Life batteries at Fire Station #107 which is on Devonshire and serves the Chatsworth and adjacent communities.
- L. **Motion:** To approve an NPG in the amount of \$1,200.00 to FPSSM for their elementary school hikes.
- M. **Motion:** To approve up to \$300.00 for printing of postcards to go in the bags given away by Adopt the City, Inc
- 5. Standing Committees: Due to the medical pandemic the committees did not meet except for the Selection Committee. The selection meeting was conducted via Zoom.
  - A. Selection Committee: Committee report.
    - All candidates who qualified for the 2020 Chatsworth Neighborhood Council selection are automatically qualified for the 2021 selection unless their stakeholder status has changed. That selection is scheduled for Saturday, March 20, 2021. Details will be provided as the selection date approaches.
  - B. To accommodate the impact of the pandemic on being able to conduct our in-person selection the bylaws will need to be amended. Recommended specific bylaw changes include: (1) all board seat terms will be modified to reflect the current situation and (2) no special selections will be held to fill any vacant seat(s) until after the 2021 selection.
