 - 1- Confirmed drug operations known by LAPD which has had the location under surveillance for an extended period of time.
 - 2- Multiple responses by LAPD for violent criminal activity
 - 3- Repeated response by LAFD for fire and rescue
 - 4- LA Building & Safety for uninhabitable conditions, no water, no sewer, and no power, and overcrowded conditions.

This is not what the people of this neighborhood or Chatsworth should be subjected to and neglected by LA City. Enforcement is being avoided and not pursued. Letter to be discussed for submission to CD 12.
