**9.** Aliso Canyon Disaster Health Research Study & Community Advisory Group discussion and motion - At the meeting held 2-3-21 of the Community Advisory Group (CAG) we will be discussing the issue of the Department of Public Health (DPH) and the handling of members of the Scientific Oversight Committee (SOC). Based on many failures of DPH, such as their failure to pursue acquiring the chemical list from SoCalGas, failure to pursue air monitoring, lack of transparency, intentional restriction of communication with the SOC and the CAG, the gaging of SOC members with regard to any and all communication with the public or others, and now with the removal of the one independent member of the SOC who was appointed as the Community representative, the following motion is being considered and we, the CAG is asking it to be considered by the CNC community.

Board discussion. The Community Advisory Group is asking that the following motion be discussed and possible action to approve:

#### Motion:

"Based on information provided to us, the Community Advisory Group, from the Department of Public Health, the Community Advisory Group, and individual stakeholders, including the current stated removal (on February 3, 2021) of the Community's most trusted advocate, from the Scientific Oversight Committee, Chatsworth Neighborhood Council is proposing a vote of "No Confidence" in the direction the ACDHRS (Aliso Canyon Disaster Health Research Study) has taken by not meeting its stated goals."
