5. 21300 – 21306 Devonshire Street. DIR-2021-4558 PAR-2021-3237-AHRF-PHP Proposed project demolition of existing improvements for construction of a 4-story affordable housing development consisting of 99 permanent supportive housing studio

units and 1 manager's unit. There will be common areas on-site property management offices, a community room, laundry facilities and outdoor of outdoor hardscape and landscape area for residents. Applicant is requesting ministerial approval processing under SB 35, development incentives per the State Density Bonus program (AB2345) Project permit compliance and Site plan review. The project site is within ½ mile (approx. 1690 feet) of the Chatsworth Train Station and qualifies for unlimited density, height increase of 3 stories up to 33 feet and no vehicular parking requirements. The proposal is showing 11 non-required parking spaces.
