Response from Eric Moody on 41.18:

In an effort to improve public safety and address the many, many complaints all the offices have received about the out of control homeless issues, Council revamped this ordinance that gives city officials some more authority in addressing complaints. It prohibits public habitation in certain locations and in others as approved by the Council after full vetting by several departments. One of the conditions involves parking within certain distances to restricted areas, buildings and driveways for businesses. It's all in the ordinance.

As I understand it, if you have specific areas or locations where we need to address community concerns, we have to draft a motion requesting a study of that area and several departments review and forward to council for council approval. Only then can we go to those areas with resource teams to address concerns. Link: <u>20-1376-S1</u>

Response from Colin Crews on RV Safe Parking:

There are no Safe Parking sites for RVs in CD12 and I know of only one in the city (and I don't believe it is open. Safe Parking for RV's is essentially setting up a mobile home park, as it would be difficult for people living in RVs to move out of a location during the day and return at night as is the practice with regular Safe Parking. Our office is always looking for locations for solutions and an RV lot certainly would be something we would be interested in.
