

2) Public Comments (Note: these comments were made prior to the roll call)

(a) Mary Kaufman spoke of the success of the trail ride hosted by Corral 54 on Sunday, March 30, 2014. Mayor Garcetti, Councilman Englander, additional City Councilmembers, Grayce Liu and one-third of the CNC Board participated in the 100 horse ride. Mary thanked everyone for their participation and handed out gift bags to the non-equestrian CNC members who participated.

Daniel Huffman complimented and thanked the organizers. He felt it put Chatsworth on the map. Lucie Volotzky thanked the organizers and expressed her enjoyment of the ride. Many others chimed in.

Matt Weintraub stepped outside from 7:10- 7:12 PM.

3) Announcements

- (a) Paul Drapkin, Senior VP of the National Association of Letter Carriers Saturday, May 10, 2014: The "Stamp Out Hunger Food Drive", the largest one-day food drive in the nation will be held. Place non-perishable food items in a bag next to your mailbox and your mail carrier will pick it up. The food items will go to your local food pantry, FISH. Watch for a card to arrive in your mailbox and please participate.
- **(b)** Jesse Fuller Sunday, June 8, 2014: The second annual "Ride the Colt" event will start at 9:00 AM from the Chatsworth Train Depot. The focus of the nineteen mile loop ride is to explore the bike paths. There are also marked, shorter bike loops. There will also be a health walk, refreshments, and give-aways. The 2013 event had 300 riders and 50 walkers participating.
- (c) Jelena Csanyi Sunday, April 6, 2014: The Chatsworth Nature Preserve will be open to the public for an Earth Day Celebration from 10:00 AM 3:00 PM. Attendance is free. Saturday, April 19, 2014: The Friends of the Chatsworth Branch Library will hold a giant book sale at the Chatsworth library from 10:00 AM -2:00 PM. Saturday, April 27, 2014: The Chatsworth Historical Society will host the Garden Festival at the Homestead Acre from 11:00 AM 4:00 PM. The Duchess Tea is from 11:30 AM 1:30 PM for \$10.00 per person. Saturday, May 3, 2014: The FPSSM is hosting the Santa Susana Trails Day. Hikes will begin at 9:00 AM, 10:00 AM, and 11:00 AM and visit educational stations along the route. Enter the Santa Susana Pass State Historic Park through the Larwin entrance.

(6) Political Representatives

- (a) Jarrod DeGonia, SFV Field Deputy for Supervisor Mike Antonovich The County Planning Commission voted to approve the Trails Master Plan into the General Plan. This will provide coordinated cohesive trails system in unincorporated parts of the SFV along with the San Gabriel Valley, Santa Clarita Valley, and Antelope Valley. It will be brought before the Supervisors in an upcoming meeting.
- **(b)** Rosalba Gonzalez, SFV Field Representative for Senator Fran Pavley She addressed the Senate Natural Resources and Water Commission regarding the need for a coordinated response to drought conditions and creating a sustainable water supply. This would include capturing storm water runoff. There are many pieces legislation in this package and all would need to go through the appropriate committee.
- (c) Megan Cottier, District Director for Councilman Mitchell Englander Councilmen Mitchell Englander and Joe Buscaino are presenting a proposal to repair the 8700 miles of streets and sidewalks throughout Los Angeles. The initiative, Save Our Streets LA, would increase the sales tax by 1/2¢ for the next 15 years. A citizen oversight committee would be established to ensure the \$4.5 billion dollar plan appropriated the funds for the targeted repairs. If SOSLA makes it on the November ballot it will need a 2/3 approval since it will be a secured funding source. Question: What happens if it does not pass? Answer: The costs for repairs double every ten years. We just can't kick the can down the road. Q: Who determines the priorities and how is this accomplished? A: Contract Administration will award outside contractors the work and this will add potentially 18,000 jobs. Since the 1990's, objective data has been gathered to grade the streets. A device analyzes the street surface as a vehicle is driven over it. The Bureau of Street Services evaluates the street surfaces in grids and completes the survey every five years. Q: What about sidewalk conditions? A: This is done on a case-by-case basis. Comment: LA has the highest business and sales taxes in the state. Ask Councilman Englander to spend time with the CNC to address these challenges. Response: Yes, I will. Q: Would the contractors be from LA? A: Contractors from LA County would receive extra points. Comment: I believe we are still paying a tax for the San Francisco earthquake. We should look at other areas. A: The 15 year sunset on the tax is specified in the ballot language. The City Council has until June 30th to approve the initiative for the November ballot. The Councilman does not take this lightly. There are limited tools to raise funds. Q: What about a re-do in 15 years if more funds are needed? A: It is anticipated \$3.6 billion will be needed for the LA repairs and completion is expected in 13 years. The sales tax will remain in effect until its sunset.
- **(d)** Leyla Campos, Director of Field Operations for DONE Congratulations on the outcome of your Selection. We can provide orientation and basic information in a 90-minute program. The Ethics training is tentatively planned for mid to late April. We are working with the City Attorney's office for a confirmed date.

7) President's Report

- (a) Andre handed each new Board member a packet with contact information, selection term length, candidate statements, approved By-Laws, and Selection Procedures. Page 9 of the By-Laws will be forwarded. He thanked Bob Dager for an excellent job in managing the selection process and in saving the CNC approximately \$5,000.
- **(b)** Selection Review, Bob Dager Chatsworth had the second highest turnout second to Porter Ranch by 40 votes. There were 690 voters casting 9,362 votes. In the Valley, there were 33 elections, our selection, and one deferred selection. The five-day challenge period passed with no challenges. There were 32 candidates and of the 21 elected each received over 300 votes. Megan Cottier thanked Bob Dager for a great job and presented him with a certificate of appreciation.
- **(c)** Installation of new board, Grayce Liu, General Manager for DONE She thanked and recognized the outgoing members. The CNC is a model for all NC's in the many community events DOTH, COLT, Corral 54's hosted ride. Grayce Liu administered the swearing in of the new board.
- **(d)** Election of officers, Bob Dager Request for nominations. Seconds are not required though permissible. If more than one nomination is received, a secret ballot will be conducted.
