Speaker – red is radioactive contamination, the rest are chemical, blue intermediate, green not really contamination except clean up requires the dirt to be moved.

Linda – Tina says that they can't find enough clean soil to fill up the area.

Nick – Can we do nothing?

Speaker – There would have to be a fence and security until natural process is done. Linda – Trucks would go out Valley Circle and toward FWY.

Dan – Is it going to Kettleman City?

Speaker – ves

Dan – Port's O'Call advanced radioactive monitors for trucks, advanced a long way from dirt escaping trucks.

Andre – We put Tina on the spot to write a complex recap. The letter will go out tomorrow from CNC so that we can go on record with DOE.

MOTION - \$2,000 NPG for FPSSM for the Third Grade Student Hikes

Bob – grateful for support of CNC, 2 schools are set up for hikes in the park, 89 students total and 19 teachers and parents came. Germain St. School is scheduled for April 17^{th} , and then submit a report to you. Asking for support for next year.

Linda – can you explain the stage coach and rock quarry?

Bob – We made our own! The kids get an idea of how it was to travel in a coach like this, and learn about the flora and fauna. But it takes 15-17 volunteers to put on the hike.

Chrissy – Sad that Private Schools and Charter Schools not included.

Bob – if we have more volunteers, we can do more schools.

Chrissy - Community hikes?

Linda – there are guided hikes.

Mel – Sierra Canvon goes on hikes.

Ted – I've seen the school hikes and volunteers do a great job, and children are in awe. A lot of the vegetation in SSM goes back to pre historic times and is not found anywhere else in the world.

Paul – what are we paying for?

Bob – Busses have gone up double, and we have to rent port-a-potties, and to get rid of the graffiti.

Dorothy – I went on the walk with Germain and it was magnificent.

Carol – We are gaining short and long term when kids learn what's in their community. Some kids have never been on a hike, and they become stewards for the future, and learn to respect.

Glen – get sheet started around – selection for CNC Sat March 18th. Not part of normal City Election, staffed 100% by volunteers, 6 hours of voting, set up and counting of ballots. Last year there was documentation requirement to vote, as simple as something that has a Chatsworth address. There is a list of approved documents on CNC website and manual. Those that don't have it can vote provisionally with 3 days to provide documentation. Also need to have a stake in the CNC, but can live in other areas.

Linda – Ongoing participation is necessary in Chatsworth Organizations.

Glen – yes, get active in the groups.

Speaker – is this based on areas that are not in the "City of LA?"

Genie – Do you know if there is county grading inspectors to do things properly? Jarrod – we have state inspectors, but we can't monitor.

Linda – do you have the name of the judge?

Jarrod – I will send it your way, but he was the one who granted the injunction.

Jarrod – This individual also had similar issues in Ventura County.

Ted – Brown's Canyon Road –is private?

Jarrod – yes, county owns property in that area now, too.
